RE: Appointment of election judges for city run special election

As the result of a successful citizen-initiated petition, the City of Littleton will conduct a stand-alone special election on March 7, 2023. This entails all aspects of conducting an election, including hiring and training of election judges. Per Littleton's city charter, Sec. 11, the Election Commission shall appoint all election judges.

To ensure the most qualified judges, the city clerk's office requested lists of judges, who might be interesting in working with the city, from Arapahoe, Douglas, and Jefferson counties of judges who have worked on past elections and have already been vetted through a background process. Only Arapahoe provided such a list. The goal was to have a minimum of 12 full-time judges for the duration of the election process and we are pleased to present thirteen judges for consideration.

Each appointed judge will receive training on responsibilities and process and will be duly sworn in as an official election judge for the duration of the March 7, 2023 special election.
