Greetings! Welcome to the City of Littleton Building Division's monthly newsletter! At the start of each month, the Building Division will deliver a comprehensive newsletter that will provide statistical information related to building permits and inspections, updates on changes within the division, and helpful and relevant information for contractors and homeowners. In this first newsletter, we will introduce you to the division and our team, talk about activities that are upcoming or underway, and provide information related to statistical data associated with the division.

### What does the Building Division do?

Generally, the Building Division issues permits, conducts plan reviews, and performs inspections of work authorized by permits.

Issuing permits involves the processing of permit applications, the calculation of valuations and fees, the routing of applications to the appropriate agencies for review, and insuring that all inspection and documentation requirements are met in order to facilitate the issuance of a letter of certificate of completion. The Building Division issues permits for residential and commercial construction, both new and renovation/remodel, as well as permits for work in the right-of-way and parking.

The plan review process consists of review by numerous divisions, departments and agencies, both internal and external, to ensure that the work proposed within submitted plan and specification documents is compliant with adopted and amended codes. The review process often involves multiple exchanges of code-related information and revised documents between team members and applicants to ensure full compliance with applicable codes prior to the issuance of the permit.

Field inspection involves the observation and inspection of work to ensure that it matches the work depicted in plans and documents approved in the plan review process, in addition to complying with the adopted building codes and amendments. Small projects may require only a couple of inspections, while larger projects can require as many as a hundred or more inspections. In addition to field inspections for compliance, building inspectors also conduct field consultations to assist in clarifying requirements when difficulties in execution of work arise, investigate incidents of work occurring without the required permits, and respond to requests for service from Fire and Police when damage to structures occurs.
