

 The 1893 Sanborn map indicates that this house was originally a square building without a porch. The porch was added between 1908 and 1914. The house was enlarged to the rear between 1921 and 1932.

HISTORICAL BACKGROUND (DISCUSS IMPORTANT PERSONS AND EVENTS ASSOCIATED WITH THIS STRUCTURE):
 This house dates to before 1893. The 1920 U.S. Census indicates that this was the home of Bert P. Cartwright, who was from England and worked as a filterman for the water company. Also living here were his wife, Minnie, and their three children. In 1932, the house was vacant. In 1939, this was the home of laborer G.W. Kemp and His wife Florence and two sons.

 This house, although somewhat altered by the addition of the porch by 1921, reflects early residential construction in Littleton through its simple design with hipped roof, overhanging eaves, drop siding, and symmetrical facade with center door flanked by windows.
