

Sales and Use Tax Report November 2022



Finance Department Issued December 19, 2022

Summary

Sales and Use taxes are the city's largest source of revenue. Changes in sales tax revenues can significantly impact the ability to provide services by the city. Reporting on tax revenues allows for monitoring of tax revenues and understanding trends.

The 3.0% sales and use tax revenues (retail sales tax, general use tax and motor vehicle tax) is used for daily operations such as police, public works, community development, library, museum, and other general operations (General Fund).

The 3.0% building use tax revenues are used for capital and infrastructure needs (Capital Projects Fund).


In November 2021, voters approved a 0.75% increase in sales and use tax to be used for capital improvement projects and was effective 1/1/2022.

Sales and Use Tax

Revenues – General Fund

There are three major components of sales and use tax revenues that are reported on a monthly basis. These revenues are the primary funding source for the daily operations provided by the city.

- Retail Sales Tax
- General Use Tax
- Vehicle Sales Tax

Retail sales tax comprises 84% of General Fund tax revenue's budget. Add general use tax and it is 88%. *This comparison does not include the 3A sales and use tax*.

November 2022 compared to November 2021:

- Retail sales tax revenues of \$3,147,406 were higher than 2021 by \$120,453 or 4%.
- General use tax revenues of \$84,043 were lower than 2021 by \$42,771 or 34%.
- Motor vehicle tax revenues of \$288,246 were higher than 2021 by \$17,465 or 6%

Overall, November 2022 compared to November 2021 sales and use taxes for the General Fund of \$3,519,695 were higher than 2021 by \$95,147 or 3%.

Year-to-date:

- Retail sales tax revenues of \$36,370,832 were higher than 2021 by \$4,291,229 or 13%.
- General use tax revenues of \$1,278,426 were higher than 2021 by \$67,737 or 6%.
- Motor vehicle tax revenues of \$2,883,843 were higher than 2021 by \$36,524 or 1%.

Overall, November 2022 compared to November 2021 sales and use taxes for the General Fund of \$40,533,101 were higher than 2021 by \$4,395,490 or 12%.

November 2022 compared to November 2020:

- Retail sales tax revenues of \$3,147,406 were higher than 2020 by \$783,986 or 33%.
- General use tax revenues of \$84,043 were lower than 2020 by \$9,692 or 13%.
- Motor vehicle tax revenues of \$288,246 were lower than 2020 by \$4,320 or 2%.

Overall, November 2022 compared to November 2020 sales and use taxes for the General Fund of \$3,519,695 were higher than 2020 by \$797,998 or 29%.

Year-to-date:


- Retail sales tax revenues of \$36,370,832 were higher than 2020 by \$9,776,958 or 37%.
- General use tax revenues of \$1,278,426 were higher than 2020 by \$56,163 or 5%.
- Motor vehicle tax revenues of \$2,883,843 were higher than 2020 by \$590,883 or 26%.

Overall, November 2021 compared to November 2020 sales and use taxes for the General Fund of \$40,533,101 higher than 2020 by \$10,424,004 or 35%.

Retail Sales and General Use Tax by Geographic Location



Retail Sales and General Use Tax Revenues Percentage of Collections by Geographical Location November 2022 (October Filing Period)




Retail Sales and General Use Tax Trends by NAICS - Industry






