8 AN ORDINANCE OF THE CITY OF LITTLETON,
9 COLORADO, APPROVING A TEN-YEAR AGREEMENT
10 WITH WORKDAY FOR A NEW ENTERPRISE RESOURCE
11 PLANNING (ERP) SYSTEM

13 WHEREAS, the current Financial and Human Resources Management Systems
14 are inefficient, pose a security risk for the city, and are significantly impacting productivity; and

15
16 WHEREAS, a new Enterprise Resource Planning (ERP) system will reduce risk
17 and will improve the operational performance for Finance and Human Resources; and

19 WHEREAS, pursuing a ten-year term represents a significant cost savings.

21 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
22 THE CITY OF LITTLETON, COLORADO, THAT:

24 **Section 1:** Council approves the ten-year term for the ERP software contract with
25 Workday.

27 **Section 2:** Severability. If any part, section, subsection, sentence, clause or
28 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
29 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
30 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
31 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
32 phrases may be declared invalid.

34 **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in conflict
35 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
36 clauses of such ordinance nor revive any ordinance thereby.

42 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the
