**Section 2:** The provisions of the annual appropriations Ordinance No. 23, Series of 2022, are hereby amended with the total of all fund expenditures amended to \$146,375,535.

**Section 3:** Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
