**AN ORDINANCE OF THE CITY OF LITTLETON,
COLORADO, AS THE GOVERNING BODY OF THE CITY
OF LITTLETON, COLORADO, STORMWATER AND
FLOOD MANAGEMENT UTILITY ENTERPRISE,
AMENDING THE 2023 LITTLETON STORMWATER AND
FLOOD MANAGEMENT UTILITY ENTERPRISE BUDGET**

WHEREAS, the city council established the City of Littleton, Colorado, Stormwater and Flood Management Utility Enterprise (the “Enterprise”) by Ordinance No. 33, Series of 2013; and

WHEREAS, the city council, as the governing body of the Enterprise, has the authority under said ordinance to establish the budget for the Enterprise; and

WHEREAS, Ordinance No. 25, Series of 2023 established the budgeted expenditures for the City of Littleton, Colorado, Stormwater and Flood Management Utility Enterprise; and

WHEREAS, Ordinance No. 07, Series of 2023, amended the budgeted expenditures for the City of Littleton, Colorado, Stormwater and Flood Management Utility Enterprise; and

WHEREAS, the necessity of receiving and expending additional monies from the Enterprise could not have been reasonably anticipated during the time of the adoption of the budget and appropriation of funds in accordance therewith.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:

Section 1: The budgeted expenditures for the City of Littleton, Colorado, Stormwater and Flood Management Utility Enterprise for the period of January 1, 2023 to December 31, 2023 are hereby amended by the following addition:

FUND	EXPENDITURES
Stormwater and Flood Management Utility Enterprise	\$1,200,000

Section 2: The total budgeted expenditures for the City of Littleton, Colorado, Stormwater and Flood Management Utility Enterprise for the period of January 1, 2023 to December 31, 2023 shall be amended to \$4,430,608.

48 **Section 3:** Severability. If any part, section, subsection, sentence, clause or
49 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
50 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
51 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
52 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
53 phrases may be declared invalid.

55 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in conflict
56 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
57 clauses of such ordinance nor revive any ordinance thereby.

61 of the City of Littleton on the 1st day of August, 2023, passed on first reading by a vote of _ FOR
62 and _ AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the
63 Municipal Courthouse and on the City of Littleton Website.

64 PUBLIC HEARING on the Ordinance to take place on the 15th day of August,
65 2023, in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at
66 the hour of 6:30 p.m., or as soon thereafter as it may be heard.
