The City Council hereby declares that it would 54 55 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase 56 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or 57 phrases may be declared invalid. 58 59 **Section 3:** Repealer.
