1 CITY OF LITTLETON, COLORADO 2 3 **ORDINANCE NO. 28** 4 5 **Series**, 2023 6 7 AN ORDINANCE OF THE CITY OF LITTLETON, 8 COLORADO REPEALING AND REENACTING 4-1-1(D) OF 9 THE LITTLETON CITY CODE, BY ADOPTING THE 2023 10 NATIONAL ELECTRICAL CODE 11 12 13 WHEREAS, the City Council of the City of Littleton desires to update the City of 14 Littleton Building Codes; and 15 16 WHEREAS, on September 20, 2023, the Building Board of Appeals of the City of 17 Littleton met in a regular meeting and recommended adoption of the 2023 National Electrical 18 Code; and 19 20 WHEREAS, the City Council deems it to be in the best interests of the public 21 health, safety and welfare that the above-mentioned code. 22 23 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF 24 THE CITY OF LITTLETON, COLORADO, THAT: 25 26 Section 1: 4-1-1(D) National Electrical Code, 2020 edition of the National Fire 27 Protection Association, is hereby repealed. 28 29 **Section 2: 4-1-1(D)** National Electrical Code, 2023 edition of the National Fire 30 Protection Association is hereby adopted. 31 32 **Section 3:** Severability. If any part, section, subsection, sentence, clause or 33 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the 34 validity of the remaining sections of this ordinance. The City Council hereby declares that it would 35 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase 36 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or 37 phrases may be declared invalid. 38 39 Section 4: Repealer. All ordinances or resolutions, or parts thereof, in conflict 40 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer 41 clauses of such ordinance nor revive any ordinance thereby. 42 43
