7 **AN ORDINANCE OF THE CITY OF LITTLETON, COLORADO,**  
8 **COLORADO, AS THE GOVERNING BODY OF THE CITY OF**  
9 **LITTLETON STORMWATER AND FLOOD MANAGEMENT**  
10 **UTILITY ENTERPRISE, AMENDING THE 2023 BUDGET**

13 **WHEREAS**, the city council established the City of Littleton Stormwater and  
14 Flood Management Utility Enterprise (the “Enterprise”) by Ordinance No. 33, Series of 2013; and  
15

16 **WHEREAS**, the city council, as the governing board of the Enterprise, has the  
17 authority under said ordinance to establish the budget for the Enterprise; and  
18

19 **WHEREAS**, Ordinance No. 24, Series of 2022 established the budgeted  
20 expenditures for the City of Littleton Stormwater and Flood Management Utility Enterprise; and

22 **WHEREAS**, Ordinance No. 07, Series of 2023 amended the budgeted  
23 expenditures for the City of Littleton Stormwater and Flood Management Utility Enterprise; and

25 **WHEREAS**, Ordinance No. 13, Series of 2023 amended the budgeted  
26 expenditures for the City of Littleton Stormwater and Flood Management Utility Enterprise; and

28 **WHEREAS**, the necessity of receiving and expending additional monies from the  
29 Enterprise could not have been reasonably anticipated during the time of adoption of this budget  
30 and appropriation of funds in accordance therewith;

33 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF**  
34 **THE CITY OF LITTLETON, COLORADO, THAT:**

36 **Section 1:** The budgeted expenditures for the City of Littleton, Colorado,  
37 Stormwater and Flood Management Utility Enterprise for the period January 1, 2023 to December  
38 31, 2023 are hereby amended by the following addition:

Stormwater and Flood Management Utility Enterprise	\$ 825,000

44 **Section 2:** The total budgeted expenditures for the City of Littleton, Colorado,  
45 of Littleton Stormwater and Flood Management Utility Enterprise for the period January 1, 2023  
46 to December 31, 2023 shall be amended to \$5,255,608.

47                   **Section 2:** Severability. If any part, section, subsection, sentence, clause or  
48 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the  
49 validity of the remaining sections of this ordinance. The city council hereby declares that it would  
50 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase  
51 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or  
52 phrases may be declared invalid.

54                   **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in conflict  
55 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer  
56 clauses of such ordinance nor revive any ordinance thereby.

59                   INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council  
60 of the City of Littleton on the 7<sup>th</sup> day of May 2024, passed on first reading by a vote of 6 FOR  
61 and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the  
62 Municipal Courthouse and on the City of Littleton Website.

63                   PUBLIC HEARING on the Ordinance to take place on the 21<sup>st</sup> day of May 2024,  
64 in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at the  
65 hour of 6:30 p.m., or as soon thereafter as it may be heard.

67                   PASSED on second and final reading, following public hearing, by a vote of \_\_\_ FOR and  
68 \_\_\_ AGAINST on the 21<sup>st</sup> day of May, 2024 and ordered published by posting at Littleton Center,  
69 Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
