12 13	WHEREAS, the city council established the City of Littleton, Colorado, Sewer		
14	Utility Enterprise (the "Enterprise") by Ordinance Number 33, Series of 2013; and		
15	ounty Enterprise (the Enterprise ) by ordinance realmost 33, series of 2013, and		
16	WHEREAS, the city council, as the governing body of the Enterprise, has the		
17	authority under said ordinance to establish the budget for the Enterprise;

19	NOW THEREFORE BE IT ORDANIES BY THE CITY COUNCIL OF		
20	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:		
21 22	THE CITY OF LITTLETON, COLORADO, THAT:		
23	Section 1: The budgeted expenditures for the City of Littleton, Colorado,		
24	Stormwater and Flood Management Utility Enterprise for the period of January 1, 2025, to		
25	December 31, 2025 shall be \$3,517,853.

27	Section 2: Severability. If any part, section, subsection, sentence, clause or		
28 29	phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would		
30	have passed this ordinance, including each part, section, subsection, sentence, clause or phrase		
31	hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or		
32	phrases may be declared invalid.		
33			
34	Section 3: Repealer. All ordinances or resolutions, or parts thereof, in conflict		
35	with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer		
36 37	clauses of such ordinance nor revive any ordinance thereby.

39	INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council		
40	of the City of Littleton on the 15 <sup>th</sup> day of October, 2024, passed on first reading by a vote of <u>6</u>		
41	FOR and <u>0</u> AGAINST; and ordered published by posting at Littleton Center, Bemis Library,		
42	the Municipal Courthouse and on the City of Littleton Website.
