8 9	COLORADO, APPROVING A FIVE-YEAR MASTER AGREEMENT WITH XEROX CORPORATION FOR PRINT
10	TECHNOLOGY, SOFTWARE, AND SERVICES

12	WHEREAS, the city requires printers for use by staff throughout the city and these
13	needs vary; and

15	WHEREAS, it is in the best interest of the city to provide multiple options when
16	selecting printers; and
17 18	WHEREAS, the city utilized a cooperative agreement for pricing; and
19	where the only utilized a cooperative agreement for pricing, and
20	WHEREAS, the City of Littleton and Xerox Corporation desire to enter into an
21	agreement to provide multi-function printers, software, and services to the City of Littleton.

24	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
25 26	THE CITY OF LITTLETON, COLORADO, THAT:
20 27	Section 1: The master agreement between the City of Littleton and Xerox
28	Corporation to provide print technology, software, and services to the City of Littleton is hereby
29	approved.
30	
31	Section 2: Severability. If any part, section, subsection, sentence, clause or
32 33	phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would
33 34	have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
35	hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
36	phrases may be declared invalid.

38	Section 3: Repealer. All ordinances or resolutions, or parts thereof, in conflict
39	with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
40 41	clauses of such ordinance nor revive any ordinance thereby.
