1 CITY OF LITTLETON, COLORADO 2 3 **ORDINANCE NO. 05** 4 5 **Series**, 2025 6 7 AN ORDINANCE OF THE CITY OF LITTLETON, 8 COLORADO, AS THE GOVERNING BODY OF THE CITY 9 LITTLETON SEWER UTILITY ENTERPRISE. 10 **AMENDING THE 2025 SEWER BUDGET** 11 12 WHEREAS, Ordinance No. 25, Series of 2024 established the annual 13 appropriation for municipal purposes for the City of Littleton, Colorado: and 14 15 WHEREAS, appropriations have theretofore been made for the expenditures of 16 monies pursuant to said budget: and 17 18 WHEREAS, the necessity of receiving and expending additional monies from the 19 general funds could not have been reasonably anticipated during the time of the adoption of the 20 budget and appropriation of funds in accordance therewith. 21 22 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF 23 THE CITY OF LITTLETON, COLORADO, THAT: 24 25 **Section 1:** The budget of the City of Littleton for the fiscal year beginning January 1, 2025, and ending December 31, 2025, is hereby amended by the following additions: 26 27 **FUND EXPENDITURES** Sewer Utility Fund \$5,159,792 Total \$5,159,792 28 29 30 **Section 2:** The total budgeted expenditures for the City of Littleton, Colorado, 31 Sewer Utility Enterprise for the period of January 1, 2025, to December 31, 2025 shall be amended 32 to \$33,559,046. 33 34 **Section 3:** Severability. If any part, section, subsection, sentence, clause or 35 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the 36 validity of the remaining sections of this ordinance. The City Council hereby declares that it would 37 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase 38 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or

Section 4: Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.
