AN ORDINANCE OF THE CITY OF LITTLETON,  
COLORADO, AS THE GOVERNING BODY OF THE CITY  
OF LITTLETON SEWER UTILITY ENTERPRISE,  
AMENDING THE 2025 SEWER BUDGET

WHEREAS, Ordinance No. 25, Series of 2024 established the annual appropriation for municipal purposes for the City of Littleton, Colorado: and

WHEREAS, appropriations have theretofore been made for the expenditures of monies pursuant to said budget: and

WHEREAS, the necessity of receiving and expending additional monies from the general funds could not have been reasonably anticipated during the time of the adoption of the budget and appropriation of funds in accordance therewith.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:

Section 1: The budget of the City of Littleton for the fiscal year beginning January 1, 2025, and ending December 31, 2025, is hereby amended by the following additions:

FUND	EXPENDITURES
Sewer Utility Fund	\$5,159,792
Total	\$5,159,792

Section 2: The total budgeted expenditures for the City of Littleton, Colorado, Sewer Utility Enterprise for the period of January 1, 2025, to December 31, 2025 shall be amended to \$33,559,046.

Section 3: Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.

Section 4: Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.



52 hour of 6:30 p.m., or as soon thereafter as it may be heard.


