1 CITY OF LITTLETON, COLORADO 2 3 **ORDINANCE NO. 19** 4 5 **Series**, 2025 6 7 AN ORDINANCE ESTABLISHING THE TAX LEVY OF 8 2.0 MILLS TO DEFRAY THE COSTS OF MUNICIPAL 9 **OF** GOVERNMENT THE **CITY** OF LITTLETON, 10 **COUNTIES** OF ARAPAHOE, DOUGLAS, 11 JEFFERSON, **STATE OF** COLORADO, FOR THE 12 CITY'S FISCAL YEAR BEGINNING JANUARY 1, 2026 AND 13 **ENDING DECEMBER 31, 2026** 14 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF 15 16 THE CITY OF LITTLETON, COLORADO, THAT: 17 18 **Section 1:** For the purposes of defraying expenses of municipal government for the City of Littleton, Colorado for the fiscal year beginning January 1, 2026, and ending December 19 20 31, 2026, there is hereby levied a tax of 2.0 mills upon each dollar of total assessed valuation of 21 the taxable property, whether real, personal, or mixed, so situated within the City of Littleton, 22 Counties of Arapahoe, Douglas, and Jefferson, State of Colorado. 23 24 **Section 2:** The 2.0 mills are levied for the following purposes: 25 26 General Government 2.0 mills 27 28 **Section 3:** To the effect and purpose that said levy mentioned herein may be 29 properly apportioned and billed, the city clerk of the City of Littleton is hereby authorized and 30 directed to notify the county commissioners of the Counties of Arapahoe, Douglas, and Jefferson, 31 State of Colorado, of the adoption and passage of this ordinance, and to certify to such officials 32 the levy herein set forth 33 34 **Section 4:** Severability. If any part, section, subsection, sentence, clause or 35 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would 36 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase 37 38 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or 39 phrases may be declared invalid. 40 41 Section 5: Repealer. All ordinances or resolutions, or parts thereof, in conflict 42 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer 43 clauses of such ordinance nor revive any ordinance thereby. 44 45 46 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council
