7 AN ORDINANCE OF THE CITY OF LITTLETON,
8 COLORADO, AMENDING TITLE 10 UNIFIED LAND USE
9 CODE, CHAPTER 9, ADMINISTRATION, SECTION 4
10 CODE AND ZONING AMENDMENTS

12 WHEREAS, City Council finds that notification of zoning changes is essential to
13 due process; and

14
15 WHEREAS, City Council wishes to expand the current notification process to try
16 and ensure that all property owners are aware of proposed additions, removals, or changes to the
17 types of uses that are available for various zoning districts; and

18
19 WHEREAS, on November 4, 2025, voters approved Charter Amendment 65.5
20 which requires first class mailings for comprehensive rezoning and zoning map amendments along
21 with code text amendments; and

22
23 WHEREAS, City Council wishes to amend our notification process for city-
24 initiated comprehensive rezoning and zoning map amendments and code text amendments to
25 reflect that the mailing will be done by “first class” mailings through the United States Postal
26 Service.

28 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
29 THE CITY OF LITTLETON, COLORADO, THAT:

31 Section 1: Littleton City Code, 10-9-4.1(D)(2)(a) is hereby amended as follows:

33 Section 10-9-4.1 Rezoning / Zoning Map Amendment

35 D. Procedures.

37 2. Council Action.

39 a. *Required Notice.* Notice pertaining to any contemplated action by the Council
40 on comprehensive rezonings and official zoning map amendments shall be that applicable
41 to the adoption of an ordinance pursuant to the City Code and City Charter. Notice of public
42 hearing before the Commission shall be in accordance with the requirements of Section
43 10-9-3.5, Public Notice. IN ADDITION, FOR ANY COMPREHENSIVE REZONING,
44 ZONING MAP AMENDMENT, OR TEXT AMENDMENT THAT CHANGES, ADDS,
45 OR REMOVES THE TYPES OF RESIDENTIAL LAND USES ALLOWED WITHIN
46 THE SLR, MLR, LLR, AND ACR ZONING DISTRICTS, MAILED NOTIFICATION
47 SHALL BE PROVIDED BY FIRST CLASS MAIL THROUGH THE UNITED STATES
48 POSTAL SERVICES (USPS) TO THOSE PROPERTY OWNERS, OCCUPANTS, AND
49 ADDRESSES WITHIN THE APPLICABLE ZONING DISTRICTS NO LATER THAN

50 14 CALENDAR DAYS PRIOR TO THE PUBLIC HEARING DATE.

52 **Section 2:** Littleton City Code, 10-9-4.3(D)(1) is hereby amended as follows:

56 D. Procedures.

58 1. Public Hearings and Recommendation. A public hearing shall be held by the Planning
59 Commission. The Commission shall make a recommendation to the Council, who shall
60 subsequently conduct a public hearing. Such public notice and hearing shall be conducted in
61 conformance with the procedures set out in Section 10-9-3.6, Public Meetings and Hearings. IN
62 ADDITION, FOR ANY TEXT AMENDMENT THAT CHANGES, ADDS, OR REMOVES
63 THE TYPES OF RESIDENTIAL LAND USES ALLOWED WITHIN THE SLR, MLR, LLR,
64 AND ACR ZONING DISTRICTS, MAILED NOTIFICATION SHALL BE PROVIDED BY
65 FIRST CLASS MAIL THROUGH THE UNITED STATES POSTAL SERVICES (USPS) TO
66 THOSE PROPERTY OWNERS WITHIN THE APPLICABLE ZONING DISTRICTS NO
67 LATER THAN 14 CALENDAR DAYS PRIOR TO THE PUBLIC HEARING DATE.

70 **Section 3:** Severability. If any part, section, subsection, sentence, clause or
71 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
72 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
73 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
74 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
75 phrases may be declared invalid.

77 **Section 4:** Repealer. All ordinances or resolutions, or parts thereof, in conflict
78 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
79 clauses of such ordinance nor revive any ordinance thereby.

82 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council

83 of the City of Littleton on the 21st day of April, 2026, passed on first reading by a vote of 5

84 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library,

85 the Municipal Courthouse and on the City of Littleton Website.

86 PUBLIC HEARING on the Ordinance to take place on the 5th day of May, 2026,

87 in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at the

88 hour of 6:30 p.m., or as soon thereafter as it may be heard.

89 PASSED on second and final reading, following public hearing, by a vote of FOR
90 and AGAINST on the 5th day of May, 2026, and ordered published by posting at Littleton Center,
91 Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
