7 AN ORDINANCE OF THE CITY OF LITTLETON,
8 COLORADO, APPROVING A NEW COMMUNICATIONS
9 CIRCUIT 3-YEAR AGREEMENT WITH LUMEN FOR A
10 DISPATCH CONNECTION TO THE STATE OF
11 COLORADO PUBLIC SAFETY RADIO SYSTEM

13 WHEREAS, the City of Littleton dispatch center connects to the State of Colorado
14 public safety radio network; and

16 WHEREAS, the State of Colorado is mandating that the City of Littleton migrate
17 to a new communication technology; and

18
19 WHEREAS, pursuing a three-year term represents a significant cost saving over a
20 two-year agreement; and

22 WHEREAS, funding for this purchase will be programmed into the annual budget.

25 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF
26 THE CITY OF LITTLETON, COLORADO, THAT:

28 **Section 1:** Council approves the 3-year agreement with Lumen for a new
29 communications circuit from dispatch to the State of Colorado public safety radio system.

32 **Section 2:** Severability. If any part, section, subsection, sentence, clause or
33 phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the
34 validity of the remaining sections of this ordinance. The City Council hereby declares that it would
35 have passed this ordinance, including each part, section, subsection, sentence, clause or phrase
36 hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or
37 phrases may be declared invalid.

39 **Section 3:** Repealer. All ordinances or resolutions, or parts thereof, in conflict
40 with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer
41 clauses of such ordinance nor revive any ordinance thereby.

44 INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council
45 of the City of Littleton on the 4th day of April, 2023, passed on first reading by a vote of 7

46 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library,
47 the Municipal Courthouse and on the City of Littleton Website.

48 PUBLIC HEARING on the Ordinance to take place on the 18th day of April, 2023,
49 in the Council Chamber, Littleton Center, 2255 West Berry Avenue, Littleton, Colorado, at the
50 hour of 6:30 p.m., or as soon thereafter as it may be heard.
