7 8 9 10 11 12	AN ORDINANCE OF THE CITY OF LITTLETON, COLORADO, REZONING A PORTION OF THE SPLITZONED PARCEL AT 5850 S. BROADWAY FROM NEIGHBORHOOD COMMERICAL TO CORRIDOR MIXED
12 13 14 15 16 17	WHEREAS , on December 2, 2024, CenterPoint Integrated Solutions, on behalf of CarMax Superstores Inc, the owner of the property described in Exhibit A, as attached hereto and fully incorporated herein by this reference, made an application for a rezoning under the provisions of the Littleton City Code; and
18 19 20 21	WHEREAS, the rezoning from Neighborhood Commercial to Corridor Mixed Use is requested to allow for 5850 S Broadway to be developed in accordance with the use standards of Corridor Mixed Use (the "Property"); and
22 23 24 25	WHEREAS the Planning Commission of the City of Littleton, CO held a public hearing on October 27, 2025 to consider the rezoning of 5850 S Broadway found the rezoning to be in compliance with the decision criteria within section 10-9-4.1 of the Unified Land Use Code; and
26 27 28 29	WHEREAS, at the Planning Commission did vote to recommend approval of the rezoning 5-0.
30 31 32 33 34	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LITTLETON, COLORADO, THAT:
35 36 37 38	Section 1: The rezoning from Neighborhood Commercial (NC) to Corridor Mixed Use (CM) of the Property complies with the Comprehensive Plan of Envision Littleton and satisfies the decision criteria within Section 10-9-4.1 of the Unified Land Use Code.
39 40 41	Section 2: The rezoning explicitly terminates and supersedes all prior zoning pertaining to the subject Property.
42 43 44	Section 3: The rezoning of the Property from Neighborhood Commercial to Corridor Mixed is hereby approved as described in Exhibit "A".
45 46	Section 4: The effective date of this rezoning shall be the date that this ordinance is recorded with the County Clerk and recorder of Arapahoe County, Colorado.

47 48 49 50	Section 5: The effective date of this rezoning shall be the date that this ordinance is recorded with the County Clerk and Recorder of Arapahoe County, Colorado.
51 52 53 54 55 56 57	Section 6: Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.
58 59 60 61 62	Section 7: Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.
