21 expenditures for the Sewer Utility Enterprise and Storm Drainage Enterprise Funds for the City of  
22 Littleton, Colorado: and

24 WHEREAS, appropriations have theretofore been made for the expenditures of  
25 monies pursuant to said budget: and

27 WHEREAS, the necessity of receiving and expending additional monies from the  
28 general funds could not have been reasonably anticipated during the time of the adoption of the  
29 budget and appropriation of funds in accordance therewith.

31 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF  
32 THE CITY OF LITTLETON, COLORADO, THAT:

34 Section 1: The budget of the City of Littleton, Colorado, for the fiscal year  
35 beginning January 1, 2026, and ending December 31, 2026, is hereby amended by the following

**Section 4:** The total budgeted expenditures for the funds listed above for the City of Littleton, Colorado, for the period of January 1, 2026, to December 31, 2026 shall be amended to \$184,547,865.

**Section 5:** Severability. If any part, section, subsection, sentence, clause or phrase of this ordinance is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining sections of this ordinance. The City Council hereby declares that it would have passed this ordinance, including each part, section, subsection, sentence, clause or phrase hereof, irrespective of the fact that one or more parts, sections, subsections, sentences, clauses or phrases may be declared invalid.

**Section 6:** Repealer. All ordinances or resolutions, or parts thereof, in conflict with this ordinance are hereby repealed, provided that this repealer shall not repeal the repealer clauses of such ordinance nor revive any ordinance thereby.

INTRODUCED AS A BILL at a regularly scheduled meeting of the City Council of the City of Littleton on the 7<sup>th</sup> of April, 2026, passed on first reading by a vote of 7 FOR and 0 AGAINST; and ordered published by posting at Littleton Center, Bemis Library, the Municipal Courthouse and on the City of Littleton Website.
