

Hello Community Gardeners:

THANK YOU for continuing to be a part of the City of Littleton's Community Gardens at either our West Shepperd (Pea Patch) location with 120 gardens, or the West Berry location with 42 plots and 5 wheelchair-accessible raised planters.

A reminder of our guidelines, fees and general information:

- Please close and lock the gate behind you every time you are in the gardens except for obviously busy times such as spring and early summer Saturday mornings.
- We will still have tillers at both gardens for you to use.
- As in previous years, the **water will be turned on in late April/early May** but may be turned off occasionally after that if we expect overnight freezing temperatures.
- All group communication concerning the garden will be sent by **email**. If you do not have an email account or infrequently look at your inbox, you will miss out on important information, fun events and educational opportunities that could help you be an even better gardener!
- We will call you individually to address major concerns and complaints.
- These are community gardens. You are part of a community, so please behave and treat other gardeners with **respect, kindness, and awareness**.
- Plot Fees remain the same from 2025. We are not currently looking at any rate changes. \$50 per plot, \$25 for raised bed or small gardens.
- All gardeners must complete **6 hours of community garden work** (weeding, plot cleanup, special projects, etc.) throughout the year at either one of the scheduled garden workdays or through other means.

LITTLETON COMMUNITY GARDEN – POLICY INFORMATION 2026

Our community gardening policies are designed to prevent conflicts, be fair to all and create a welcoming, enjoyable space where everyone can peacefully pursue their love of gardening.

Community gardens are open year-round.

RESIDENTIAL REQUIREMENT: All gardeners must live or work within the city limits of Littleton. If you are assigned a garden, you must be the primary active gardener. Reserving a garden plot for someone living outside the Littleton city limits is prohibited.

COMMUNITY WORK HOURS: All gardeners must **complete 6 hours of community garden work** (weeding, plot cleanup, special projects, etc.) throughout the year at either one of the scheduled garden workdays or through other means. We will schedule a minimum **of 3 different workdays in May, July, and September** on Saturdays. You will need to work a total of 6 hours, and hours can be divided between any of the 3 days. Additional opportunities are available for those who cannot make the garden workdays as scheduled. Please reach out to Jennifer Dawe if you have any issues completing the hours so other accommodation can be arranged. Failure to complete work hours, make payments, or adhere to policy guidelines may result in forfeiture of membership. The dates, times, and activities for each garden workday will be sent out in March.

ALCOHOL: Alcohol consumption is **strictly prohibited** in the Community Gardens.

FEES: A fee of **\$50.00** per garden, **\$25** for a half plot, **\$15** for 4x8' raised planters will be paid to the City of Littleton for each calendar year or portion thereof. No refunds will be made.

PLOT NEGLECT: Gardens are to be planted by June 15th. On June 1st, if your garden is not already planted or prepped for planting (meaning free of all weeds) you will be given a warning. **Your plot will be reassigned if the issue has not been addressed by June 15th.** In the case that gardeners neglect their plots and responsibilities we will attempt to reach out three times, if no contact is made, your plot will be considered abandoned and reassigned. Additionally, if contact has been made and action has not been taken within 5 days, your plot will be reassigned. **If for some reason you are unable to plant or tend your garden for an extended period (due to illness, vacation, etc.) please notify the city (303-795-3952).** It will be the gardener's responsibility to keep their plots clean, litter free, weeded, and mulched. **Gardeners are also responsible for keeping adjacent aisles clear and weed free.** Volunteer flowers, especially sunflowers, must be removed or controlled so as not to block the sun from adjacent plots or block aisle access.

PLANT RESTRICTIONS: Plants that spread or are invasive should be **planted in pots** within the gardener's plot. **No invasive vines** should be planted in any scenario. **No trees** are allowed unless they are already present. Gardeners are to only plant within their assigned plot(s). Failure to do so may result in the reassignment of the plot.

TRASH: Remove all non-compostable trash from your garden after each visit. Organic materials may be composted on-site or hauled away and disposed of. **Do not dump any trash (organic or inorganic) outside the fence on site unless you have specific permission from the city.**

COMPOST: We have partnered with a local company that will be hauling garden organics off-site once a week. This is for any plant material generated within the garden. In exchange, we will have the large **compost drop** in the spring and small compost drops throughout the season for use. If you have a metal basket that was provided by us and would like to continue composting on your own, you are welcome to do so, otherwise, please let me know if you need us to pick up a basket that you no longer need. If you choose to keep your private compost, **please note that you are fully responsible for maintaining it.**

PESTICIDES AND HERBICIDES: **The use of pesticides and herbicides is strictly prohibited.**

FERTILIZERS/TILLING: Soil amendment and tilling are the responsibility of each gardener. We may schedule **free compost deliveries** in the spring as a first come/first-served bonus to gardeners. There will be a community tiller in the shed. We will do training in early spring on tiller use for those interested and gardeners are free to use the tiller at their convenience.

CHILDREN & PETS: Children are encouraged to participate in the family gardening experience, but they must always be supervised. Please respect the plots of other gardeners. Do not let children trample or visit neighboring gardens unless invited by those gardeners. Pets are prohibited in the gardens **except for approved service dogs.**

WATER LINES/HOSES: Water lines, Y and V connections, are installed by the City of Littleton. If a break or leak in the lines occurs, please contact the City of Littleton (City Shops 303-795-3969; 7:30 a.m. – 4:00 p.m., Monday-Friday. To report an **EMERGENCY** water leak on weekends or after work hours please call 303-808-9678). Hoses will not be provided to individual gardeners. **Please do not cover or alter any of the city's irrigation boxes which are painted blue and dispersed throughout the garden.** Gardens may only be watered with a hand-held hose with a shut-off valve **or by drip irrigation, and the water shall not be left on or unattended at any time.**

THEFT OR VANDALISM REPORTING: Please call **303-794-1551** (Police non-emergency phone number) to report theft or vandalism if you see it occurring. The gardens are open during daylight hours only.
